#### **FAQs and Answers**

#### 1. What is the NSW ICC T20 World Cup 2020 Legacy Fund?

This is an initiative established in 2018 by the NSW Government to be administered in the lead up to the ICC T20 World Cup 2020 tournament. The establishment of a legacy fund will help to ensure communities across the state have the opportunity to benefit from NSW hosting 14 matches throughout the women's and men's tournaments.

# 2. How much funding is available?

A total of up to \$2 million will be provided this financial year, with the minimum and maximum amounts available varying between funding streams.

All Applications will require a minimum 50% co-contribution from applicants or their partners

#### 3. What are the funding opportunities available?

This funding provides an exciting opportunity for councils and local clubs to consider projects that provide long-term benefits to local communities. Funding is available for projects that seek to:

- Improve the quality and/or quantity of cricket facilities in NSW,
- Improve female participation pathways for players, officials and coaches through the implementation of new or enhanced programs; or
- Ensure that regional NSW locations meet requirements to host elite state and national level events.

#### 4. When do applications open and close?

The Key dates and assessment process is as follows

Program Opens: 9am Wednesday 22 July 2020

Application Closing Date: 5pm Monday 24 August 2020

Notification of Outcomes: October 2020 onwards

Projects Commence: no later than 1 May 2021

Projects Must be completed: By 30 June 2022

#### 5. What changes are there from last year's funding round?

There are no material changes to this grants program from last year.

#### 6. Does having a partner mean they need to contribute financially?

No, partners can be any relevant organisation which is supportive of the project and will assist with implementation in some way.

For infrastructure projects for example, Councils should seek support from local Clubs/Leagues/Associations and Cricket NSW for input into the planning and design of facilities.

For female programs, clubs/associations should seek support from Cricket NSW Cricket Managers to ensure that projects are align with strategic priorities of Cricket NSW and Cricket Australia.

For regional events, All applications must include a letter from CA or CNSW, along with land owners (if applicable), confirming support and/or sanctioning of the event and that all venues meet the hosting requirement of the proposed event content.

### 7. What evidence should I provide to support my application?

<u>Financial</u> - If any funding source is over \$10,000 evidence should be provided via a bank statement, letter confirming funding support etc.

<u>Infrastructure</u> – Development approvals, land owner consent, images of current facility, plans/impressions of the completed project, quotes etc.

Project Support – Letters of Support from partners, participation data.

#### 8. How do I know if my organisation is incorporated?

You club/association treasurer should have a certificate of incorporation, or you can search for your incorporated status here: http://associationspr.fairtrading.nsw.gov.au/

#### 9. Must my organisation have an ABN to be eligible?

No. However, to receive grant payments successful applicants will require an ABN or provide a Statement of Supplier form. These can be downloaded from: ato.gov.au/forms/statement-by-a-supplier-not-quoting-an-abn

# 10. If my organisation isn't eligible, can the project still be considered for funding?

If an organisation is not eligible, they can partner with an eligible organisation who will have to submit the application.

# 11. The infrastructure project we are seeking funding for is part of a larger precinct development. Is this project eligible?

Staged components of a larger facility development are eligible, providing the stage being applied for meets the program criteria.

## 12. Can voluntary Labour and in-kind support count towards our cocontribution?

Yes, consideration will be given to claiming in-kind expenses to a maximum of 20 per cent of the total project cost.

# 13. We've received money from another NSW Government agency for this project, can we still apply for funding?

Projects that receive funding from another NSW Government agency/program are ineligible.

#### 14. When must the project start and finish by?

Projects must commence by 31 May 2021 and be completed by 30 June 2022.

Retrospective funding requests are also ineligible. This is where projects have commenced construction or are completed prior to 24 August 2020 (construction includes, but is not limited to, site clearing, earthworks and building works)

#### 15. Is an infrastructure project on private land eligible?

Projects on private land are eligible, but will be subject to the establishment of a legally binding agreement between the organisation and local council to ensure ongoing public access. Such proposals should demonstrate evidence of a legally binding agreement in the Full Application.
