## SHOOTING RANGE CONDITIONS:

- 1. The range is inclusive of the range and the Range Danger Area (RDA).
- 2. The approval holder must not operate the shooting range in contravention of any conditions to which this Range Approval is subject.
- 3. The approval holder is authorised to operate the shooting range only at the location Range Road, **CECIL PARK** NSW 2178 and only for the purposes specified in the range approval.
- 4. Unlicensed persons shooting on the range **under the provisions of section 6B of the** *Firearms Act 1996* and clause 129 of the *Firearms Regulations 2017* must at all times be under the direct supervision of a suitably licensed supervisor. In this regard, 'direct supervision' is one unlicensed person to one licensed supervisor.
- 5. The Range Approval holder is responsible for ensuring the safety of all persons utilising the range, irrespective of supervision requirements and in accordance with public safety provisions under the *Firearms Act 1996*. This condition extends to the Range Approval holder having control over the use of the shooting range (including the RDA), pursuant to clause 92(d) of the *Firearms Regulation 2017*.

- 6. Permissive shooting rights and local consent authority sought in relation to this approval must remain current. Any withdrawal of permissive shooting rights or local consent authority will result in the suspension and/or revocation of the range approval.
- 7. The authority of this approval remains in force from the issued date until the expiry date specified above, unless it is sooner revoked or otherwise revised and ceases to be in force.
- 8. Any proposed alterations or additions to the range after the issue of the Range Approval must have the prior written approval of the Firearms Registry. This condition extends to any desired or necessary alterations to the RDA or the location of the range.
- 9. Any incident or accident-causing injury to a person or property damage, involving the possession or use of firearms on the range <u>must be reported to Police immediately</u> and separately to <u>NSW Police Force Firearms Registry Range Unit within 48 hours.</u> This requirement is legislated under clause 94(1)(c) of the *Firearms Regulation 2017*.
- 10. Only the approved ammunition listed on this approval is to be used on the range. Any ammunition not listed on this approval is not to be used as it will not be contained within the RDA and may cause danger to life, limb or property.

- 11. Hard targets' i.e., steel targets, when is use on the range the steel targets are to be protected by a "shroud" or overhead canopy that is ballistically rated to capture fired ammunition that ricochets at 45° angle off the steel target.
- 12. The approval holder must notify the Firearms Registry, in writing, within seven (7) days of closure of the range or a change of address or contact details of the approval holder.
- 13. The shooting range may be inspected at any time by Compliance & Enforcement Officers (Firearms Registry), a Police Officer or such other persons as nominated by the Firearms Registry.
- 14. The approval holder must furnish any documentation relating to the control, administration, management, operation and use of the shooting range at any time upon request of the Compliance & Enforcement Officers (Firearms Registry), a Police Officer or such other persons as nominated by the Firearms Registry.
- 15. NSW Police officers are authorised to possess and use firearms on this shooting range for the purpose of training or instruction in the ordinary course of their duties as employees of the NSW Police Force.
- 16. NSW Department of Corrective Services Officers are authorised to possess and use firearms on this shooting range for the purpose of training or instruction in the ordinary course of their duties as employees of NSW Corrective Services.
- 17. NSW Security company employees undertaking testing or accreditation with pistols/shotguns are authorised to use the range, but only under the personal supervision of the holder of a NSW Firearms Instructor Permit.

- 18. NSW Licensed Firearms Dealer / Club Armourer authorised to possess and use firearms on a specified shooting range for the purpose of testing firearms registered to the firearms dealer licence, may use the above-named range under the supervision of the Range Approval holder or other licensed person nominated by the approval holder.
- 19. The Firearms Registry may vary or revoke these conditions or attach additional conditions on the Range Approval at any time, by written notice served in person or by post addressed to the approval holder.
- 20. A copy of this Approval is to be displayed in its entirety in a prominent position at the range.
- 21. A copy of the Range Standing/Safety Orders is to be displayed in its entirety in a prominent position at the range.
