1. HOW TO MAKE A REPORT


Any member of the community who suspects, on reasonable grounds, that a child or young person is at risk of significant harm should report their concerns to the Child Protection Helpline (13 21 11).

The Child Protection Helpline is a 24-hour state-wide contact centre which receives calls relating to the suspected abuse and neglect of children and young people.



Reports may be made to the Helpline by the **general public** and **mandatory reporters**.

The diagram below outlines the Reporting Process.



2. RISK OF SIGNIFICANT HARM

What is Risk of Significant Harm (ROSH)?

- Significant harm serious enough to require a response by a statutory authority regardless of a family's consent.
- Harm that is likely to cause a substantial negative impact of the child or young person's safety, welfare and wellbeing.
- It may be the result of a single incident or accumulation of these.

3. TIPS FOR QUALITY REPORTING

Quality reporting keeps children safe and supported. We provide the following guidance on how to make a quality report to the Child Protection Helpline:

- 1. Ensure you have all of the identifying details
- 2. Provide an outline of the details of the incident
- 3. Describe the impact on the child or young person
- 4. Use simple language
- 5. Don't assume the Helpline caseworker already knows the information
- 6. Provide direct quotes.
